**Event Fees:** The fee is \$70. Skaters may skate only one event. No refunds will be made in accordance with rules 3233 and 3235, or due to acts of god. Payment may be made via Check, Money Order to Champlain Valley Skating Club (CVSC) or via Credit Card (MC or Visa). Late registration fee for applications postmarked after September 21, 2009 is \$35. Late applications must be approved by the LOC and/or Chief Referee.

**Credentials:** A credential is required for access to competitor areas. Each registered competitor will receive one coach, one chaperone and one competitor credential. Additional credentials for coaches and/or choreographers are available for an additional \$20 per person. Replacement credentials will be supplied at a cost of \$20 per credential.

To receive a coach credential, all skating professionals must comply with the USFS rules requiring the completion of the Coach Registration process including background check and liability insurance. Professionals not registered with US Figure Skating will not be allowed to enter areas requiring credentials including locker rooms and rink side.

**Ticketing:** Tickets are required to attend this competition. Ticket prices are as follows:

All Events (non-qualifying and qualifying).....	\$20
Single Day Ticket.....	\$5
Children 4 and under.....	Free

**Music:** CD's only will be accepted. The skater's program must be the only music on the CD and clearly marked (no stick on labels) with name, event entered and music length. All CD's must be turned in to the registration desk at least one hour before the scheduled event time. Skaters must have an extra CD available at ice edge in case of emergency.

**Awards/Medals:** First through fourth place will receive a medal for each flight. If the referee determines a final round is necessary due to the number of competitors, only the final round shall receive an award.

**Qualifications:** All skaters in good standing with US Figure Skating are eligible to participate in this competition. Test qualification as of the date of closing of entries, **September 21, 2009**, shall be used. For the Free Skate Track events, competitors must skate at their test level, Test Track skaters may skate up one level. Skaters may not take a test after the closing date of entries.

All competition events will be governed under the 2009-2010 USFSA Rulebook. The local organizing committee reserves the right to limit the number of entries in a category and to combine or divide groups as necessary. The local organizing committee may eliminate events due to insufficient entries or limitations on the availability of ice time.
